## Integration of Perfect Gift.Org (PGO) and the Private Banking Facility (PBF)

YAHUWAH is *Light* [1 John 1:5], and in His *Light* is the infinite totality of YAHUWAH Aloahiyim's attributes, including but not limited to: Truth, Righteousness, Love, Assurance of Trust, Perfection of all Creation, Divine Counsel with Prudent Understanding, etc. All good and perfect gifts come out of His *Perfect Light* [James 1:17]. His *Light* was placed into man's spirit at birth [John 1: 4, 9]. In this world, YAHUWAH'S *Light* is already there waiting to be manifested in any situation or circumstance. While man is waiting on Aloahiyim, Aloahiyim is waiting man . . . those that truly belong to Him, and He knows who they are.

***The goals of PGO are simple*** . . . that is, for each and every ***PGO Member*** to experience the rejuvenation of his or her spirit pursuant to the release of YAHUWAH'S *Light* from within, the illumination of their respective soul, and the perfect restoration of perfect health in their bodies, followed by a resolute determination by each ***PGO Member*** to become a part of the ***Man Child*** that is be caught up to the Throne Room of YAHUWAH Aloahiyim [Rev 12:5]. ***To be a part of the Man Child is, or certainly should be . . . the single most important goal for any individual, bar none.***

All that is NOT pure *Light* is darkness or some measure thereof, and nothing good that ***lasts*** ever comes out of darkness. Without exception, darkness is the common source of any and all problems of any kind. However, YAHUWAH'S ***Light always, always vanquishes darkness.*** Hence, ***PGO*** endeavors to incite ***each and every PGO Member*** . . . to ***experience and see*** His *Light*; and precisely what the experience of His *Light* means with clear and prudent understanding in every aspect of their respective lives. ***This experience of YAHUWAH is a continuum;*** ongoing, not intermittent and not static. The experience of YAHUWAH'S *Light* is to move into His essence; to not just perceive, but to ***experience an explosion*** of YAHUWAH'S life giving, almighty power and majestic source of all Creation.

***PGO*** and the ***PBF*** function together as an instrument to bring YAHUWAH'S people to literally apply and exercise the scriptural demands of ***2 Cor 10: 3-6***. Included within YAHUWAH'S *Light*, is the equipping of all believers to press higher, deeper, and further into His *Light* from within their own respective spirits. This is a choice made by each believer, and an act (exercise) of their respective free will. One does not see YAHUWAH'S *Light* until he or she is in His *Light* [Psalm 119:130; 36:9].

YAHUWAH'S *Light* moving through ***PGO Members*** causes the ***PBF*** to become a seamless operation within His *Light*. As the ***PGO Member/PBF Participant*** walks in obedience to His Word and instructions, then they become the beneficiary of His *Light*. All ***PBF*** management functions, operations, and decisions, are performed by ***PGO Members*** who are held directly accountable to Aloahiyim [Rom 13:1-2]. Otherwise, the ***PBF*** would yield the same imperfections as any other business venture conceived of by man, ultimately yielding corruption and a path of evil, absent YAHUWAH'S *Light*.

In short, the ***PBF is a Ruach driven enterprise*** of YAHUWAH Aloahiyim available only to ***PGO Members***. The longer each ***PGO Member*** consciously (soulishly) exercises being in His *Light* [2 Cor 10: 3-6] then the

more of YAHUWAH'S *Light* they absorb into their respective spirits, and correspondingly, the greater amount of darkness is driven out of and from around their respective souls and personal circumstances. The more of YAHUWAH'S *Light*, then the more of His favor in a tangible form.

***This is the function of the PBF:*** it rewards ***PGO Members*** who are ***PBF Participants*** who conduct every aspect of their lives in YAHUWAH'S Righteousness (*Light*), rather than enabling them to circumvent it. The ***PBF*** functions in obedience to YAHUWAH'S Righteous laws to prevent losses, and safeguards all capital and earnings through indemnification from within the mechanics of ***PBF*** operations. Thus, the ***PBF Participant*** enjoys the shalom of the Father that surpasses all understanding [Phil 4:7] in all areas of their life by watching for Him to perform on His Word [Jer 1:12; Ezek 12:25]. In addition to YAHUWAH'S shelter from economic loss, ***PBF Participants*** also enjoy growth and earnings that are a function of His *favor* on an individual level (as a result of obedience to His Word and His Righteousness). These results can be, and are . . . tangible and quantifiable in the realm of the natural (everyday life this world).

In other words, YAHUWAH protects all ***PBF*** assets and earnings from losses due to risks commonly associated with the worldly practices of the business and financial markets. In connection with conventional business and finance, business decisions often require taking certain calculated risks. These risks are either reduced or eliminated altogether; while maintaining a superior return on capital contributions. In other words, each ***PBF Participant*** is ultimately rewarded based on the level, purity, and intensity of YAHUWAH'S *Light* at work in each ***PBF Participant*** [Eph 4:17-18, 22-23].

Hence, the *total reward package* is a function of obedience to YAHUWAH'S Righteous code of behavior in connection with one's total life; the greater the effort the ***PBF Participant*** endeavors to press spiritually higher, deeper, and further into YAHUWAH'S *Light*, then the greater the reward of YAHUWAH'S *Light* being manifested in their spirits, as well as the reward through the material results of the ***PBF*** [Ezek 36: 25-27].

Thus, both ***PGO*** and the ***PBF*** operate as a seamless instrument in the hands of YAHUWAH. In short, the favor and tangible results even of the ***PBF*** are derived from . . . and out of YAHUWAH'S *Light* [Zech 4: 6-10]. YAHUWAH'S *Light* is the centerpiece of the ***PBF*** operating capability; yet this is ***NOT*** some mystical formula where there are no definitional boundaries. Darkness (in, of, and around the soul) cannot lead YAHUWAH'S *Light*; and one cannot separate business and financial affairs from the Word of Alohiym anymore than life can be separated from breath (in this dimension).

***PGO*** empowers ***PBF Participants*** to keep from racing down rabbit trails where people (of the world) are fed a delusion [2 Thessalonians 2:10-12]. Alohiym deliberately left Pharaoh in place to strengthen Moses; and so YAHUWAH has done with the world systems of today. As YAHUWAH'S *Light* was revealed through Moses but was veiled [Exod 34: 33-35], it is YAHUWAH'S desire that all ***PGO Members*** and ***PBF Participants*** have no veil [Isa 60:1-4], allowing His *Light* to manifest as YAHUWAH desires for each respective party.

The ***PBF*** is a *first fruits* demonstration, analogous to technology that improves with time and use. As the ***PGO Member*** walks in YAHUWAH'S *Light*, then (and only then) does His *Light* grow in intensity, brilliance, and power in each ***PGO Member***. As YAHUWAH'S process of illumination continues, the ***PGO***

**Member** is able to soulishly (consciously) discern that the Messiah and the Father have formed His (their) abode in each true believer [John 14: 21, 23; 2 Pet 1:4; Luke 2:32]. This revelation is necessarily life-changing.

The Messiah came to this world, walked in physical form, died and resurrected for the *Lost House of Israel*. The *Lost House of Israel* is open to all persons who are willing to receive their respective salvation made possible by the Messiah's death and resurrection. The Messiah and the Bride (*Man Child*) say (together) . . . come [Rev 22:17]; and whosoever will.

**PGO Members** are chosen to be on YAHUWAH'S team and serve in *His* war against darkness. Pursuant to that team effort, **PGO Members** assist in the harvest of souls because the laborers are few [Matt 9:37; Luke 10:2], while simultaneously further advancing into His infinite *Light*. This too brings YAHUWAH pleasure, and He expresses His pleasure in His love that is necessarily a part of His *Light*.

**PGO Members** are empowered through the Word to overcome, adapt, and move forward into His *Light* (Truth) [Psalm 119:130, 105]. Truth (*Light*) is not learned, it is experienced. This is precisely why man prays. YAHUWAH'S *Light* is infinite, and **PGO** is designed and positioned to act as a catalyst for the **continuous explosion** of YAHUWAH'S *Light* that belongs to YAHUWAH alone that is in each and every **PGO Member**. Thus, YAHUWAH alone receives any and all credit for that which is the direct result of His *Light*.

YAHUWAH is calling **PGO Members** out of *mixture* of light and darkness (mixture = darkness) and into the *Realm of the Ruach* (PURE LIGHT . . . necessarily NOT that of *mixture*) where there is pureness of Truth, Righteousness, etc. Not all persons will answer the call, but all **PGO Members** will have the opportunity. *Destiny* is defined as YAHUWAH drawing the map for one's life, and it is the responsibility of the **PGO Member** to follow it. YAHUWAH'S Word is that map. Although some people will fall off, some people will get back on; but not all. Thus, the heart and soul of each **PGO Member** is tried and tested.

The **PBF** is both a mile-marker on the roadmap and a resting place in the natural. If during the time a believer here on the earth sees His *Light* . . . it is because he or she is in YAHUWAH'S *Light* [Psalm 36:9]. While the **PBF** is of the natural, the physical elements of this world come to be perceived as nothing more than a wall and a barrier to the personal experience of YAHUWAH'S *Light* (in each individual spirit); with the construction of these walls becoming more and more realized and understood as temporary and unimportant [2 Cor 4:18]. Focus on the temporary is necessarily a bad investment of time, effort, and opportunity of the one life that each person has been given by YAHUWAH.

The revelation of 1 Cor 4:7 becomes magnified in that man receives nothing other what YAHUWAH provides, and therefore how can he (man) boast. The experience of YAHUWAH'S *Light* underscores the reality that every good and perfect gift is from above, coming down from YAHUWAH, the Father of Lights [James 1:17].

There is no substitution for YAHUWAH'S *Light* just as there is no substitution for life . . . *no light, then no life*. Now to the carnal mind, this rationale does not make sense. However, YAHUWAH has an easy way to address this, but it is not His desire that any soul should perish [John 12:47; 2 Pet 3:9]. Thus, **PGO** is

an instrument of YAHUWAH to bring forth the validity of His Word using the **PBF** to clearly identify where the treasures of the respective heart are **[Matt 6: 19-20]**. As this realization is perceived by the **PGO Member (PBF Participant)**, then the movement into the *Man Child* **[Rev 12:5]** becomes clearer, and far more urgent.

The movement of persons without reservation or compromise into the *Man Child (aka: Bride, Manifested Sons, Overcomers, etc.)* constitutes the greatest move of YAHUWAH since the Day of Savuot (Greek: *Pentecost*). **PGO**, with or without reference to the **PBF**, prepares **PGO Members** to become a part of this select group, but only if they are willing. Otherwise, the **PBF** would simply constitute another financial program. Thus, each and every **PGO Member** as well as **PBF Participant** must necessarily focus on YAHUWAH'S *Light* in order to make any progress in their respective lives, spiritually and materially.
